

WHAT IS APPALRED?

Appalachian Research and Defense Fund of Kentucky, Inc. (AppalReD) provides free legal help for people and groups who cannot afford a private attorney.

AppalReD charges no fees. However, sometimes a client might have to pay court costs.

AppalReD is funded by the Legal Services Corporation in Washington D.C., the Commonwealth of Kentucky, Kentucky Interest on Lawyers Trust Account (IOLTA) funds, other federal funds and private donations. In some cases, services may be provided by a private attorney who has volunteered his/her time or who has contracted with AppalReD to provide services on a reduced fee basis.



WHO IS ELIGIBLE FOR HELP FROM APPALRED?

To be eligible for free civil legal help from AppalReD you must:

1. Have an income that meets the federal poverty guidelines. These guidelines vary depending on the size of your household.
2. Have a type of civil case that AppalReD handles.
3. Live in one of the following 37 counties:
