"For too long, financial constraints made it feel impossible to take the first steps toward a divorce, even though I knew that creating a healthier future depended on it. Legal aid gave me the resources and confidence to begin a process that had once felt insurmountable.

It meant I could finally assert my right to be an active, present parent—seeking joint custody so that my daughter could continue to have both love and stability in her life.

FAIR HOUSING

Bobby keeps his small subsidized apartment tidy and always pays rent on time. Living with anxiety and on oxygen, he brought home Sadie, an emotional support dog.

When his landlord tried to evict him, saying Sadie was the "wrong breed" and "overweight," Bobby didn't know where to turn. Then he called AppalReD Legal Aid.

His attorney fought the eviction, educated the landlord about the Fair Housing Act, and made sure Bobby and Sadie could stay home together. Bobby now has a lease that includes Sadie.

Now Bobby knows he has Sadie and an AppalReD lawyer at his side.

Using an interpreter, AppalReD's clinic coordinator helped her complete the forms and explained all the steps of filing. When Silvia got a call from the court that her divorce papers were ready, she picked them up within the hour!

In less than a week, she ordered an updated social security card, and changed her name on her driver's license, bank accounts, and rental paperwork!

From full of nerves to full of confidence, Silvia's divorce propelled her towards a bright future!


