

Attorneys offer advice on escaping domestic violence

FLOYD COUNTY, Ky. (WYMT) - Eastern Kentucky attorneys are offering advice to people trying to escape domestic violence after one Laurel County woman was murdered by her husband Tuesday night at their home. "What we try to do is make a difference victim by victim, to try to end domestic violence and that's hopefully where we're going as a society," said Executive Director of Appalachian Research and Defense Robert Johns. Shannon Mills was murdered by her husband after they got into an argument at their home south of London. Mill's co-workers said Mills was one of a kind but was stuck in an emotionally abusive relationship before her death. Johns and Appalachian Research and Defense attorney Kelly Wallen told WYMT they see more than 100 domestic violence cases in a year. They explained that a victim's environment could factor into why many victims do not report their cases. "What I'm finding more often now is families are not exactly supportive of the victims. They don't understand what they're going through, they haven't seen it first hand because so much of this is done in private," said Wallen.

Wallen said much of the time victims also lack transportation and financial independence to leave their situation.

"That's a big concern, usually the abuser is the sole financial support so the victims don't know how they're going to live once they do leave," Wallen said.

Appalachian Research and Defense is just one option for victims to get the help they need.

"I would encourage victims to reach out and see what's out there in terms of services. Because there are many agencies and people out there who are willing to help and try to get them to a better life," said Johns.

The center provides victims with legal help, finding a job and finding a place to stay among other things.

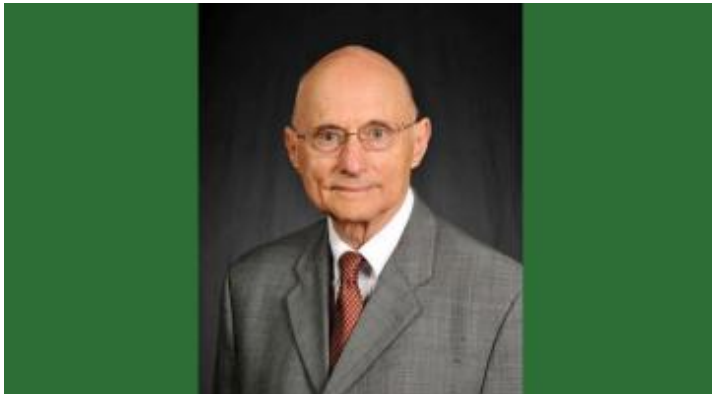
