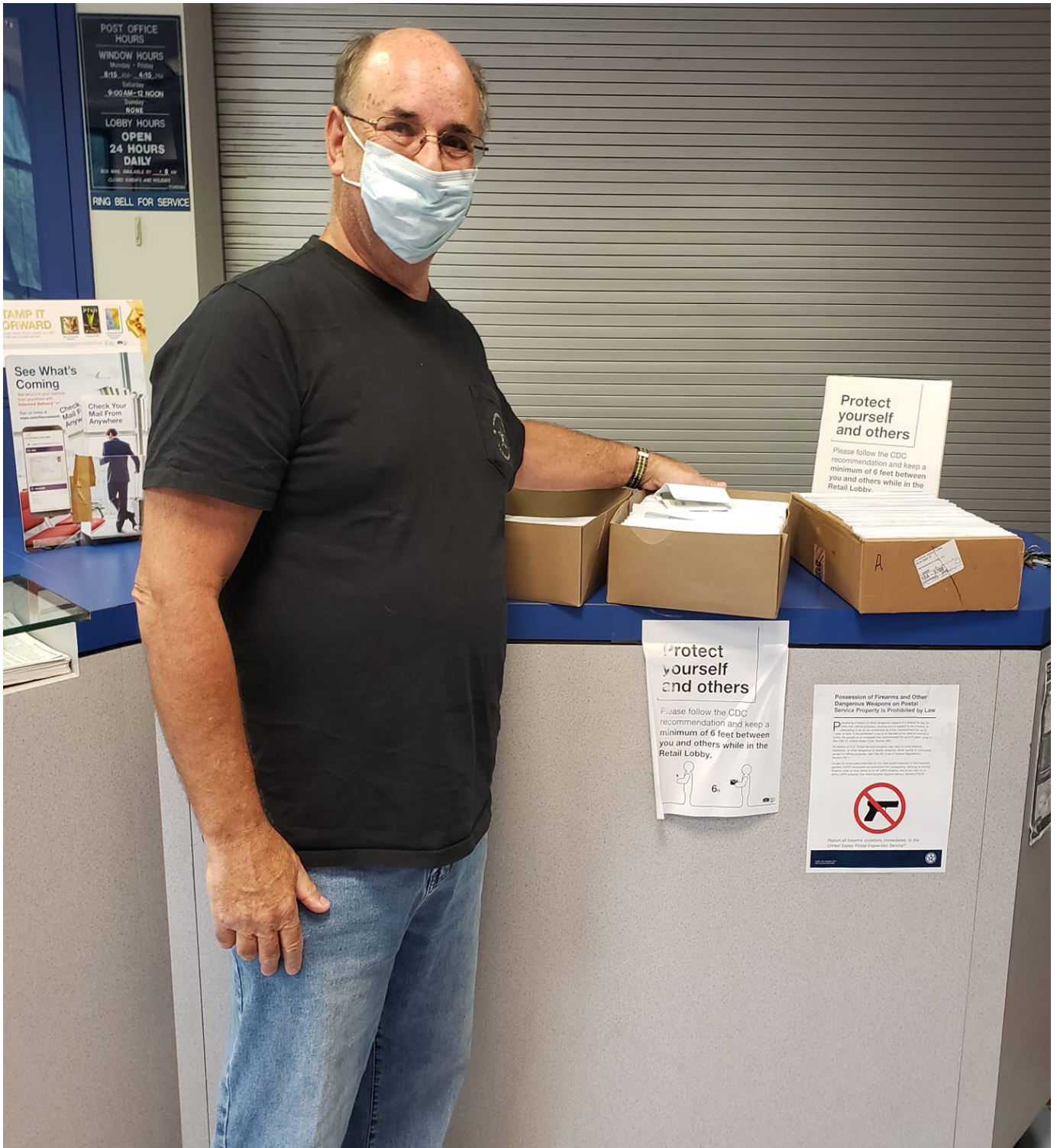


# Thousands of Eric Conn client share checks mailed out by Prestonsburg attorney
