## **YOU ARE NOT ALONE.**

You deserve someone in your corner as you fight for court-ordered protection.

We have successfully won custody for survivors who are in same-sex relationships.

Some abusers will say that our area of Kentucky is too homophobic to help or that police won't help. The service providers we work with are welcoming and trained to meet the needs of the LGBTQ+ community. We have strong relationships with the police and courts. We care about YOU.

## **WE BELIEVE YOU.**

Domestic violence can happen to anyone--no matter your gender, orientation, income, or education. Domestic violence is about power.

Domestic and dating violence in the LGBT+ community takes many forms--from threatening with violence or to out you to family and friends. It can involve physical violence, sexual assault, and stalking.

## **YOU DECIDE.**

You decide whether to:

- File charges.
- Seek a protective order.
- Pursue custody

You decide if we can advocate for you by having conversations with an employer, landlord, or school officials.

You decide if you would like us to connect you with counseling.

You decide to disclose your sexual orientation. Our intake specialists ask every caller their sexual orientation.



Misty separated from her husband due to his violent rages. However, he continued to threaten her and the children. When she started to date a woman, it got even worse.

Unlike many survivors, Misty didn't have to go to court alone. Together we won an extended protective order and sole custody. She doesn't know what the future holds, but she is looking forward.

## MOVE FORWARD

If you cannot return home, along with our partners, we can help you obtain housing.

We can help with financial difficulties:

- rental deposits,
- turning utilities on,
- repairing credit, or
- cost of changing locks.

We can help with getting copies of identification documents that were left behind so you can:

- enroll children in school,
- obtain public benefits, or
- seek health care.

We can assist with having your I.D. changed to reflect your gender identity.

We can provide gas cards if you need help getting to court or meeting with your attorney.

We can also help with:

- Expungement of criminal records
- Education discrimination or bullying of LGBT youth
- Consumer issues, bankruptcy, eviction
- Public Benefits and Health Issues

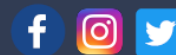
