# EASTERN KENTUCKY DISASTER ASSISTANCE

Accelerate your FEMA appeals process – Join us in person for valuable assistance in Eastern Kentucky.

To ensure a swift review, please bring the following:

- FEMA determination letters
- Proof of ownership (deed, title, property tax receipt, etc.)
- Proof of occupancy (utility bill, rental receipts, etc. between 5/2022-7/2022)
- Proof of address (driver's license, pay stub between 5/2022-7/2022)
- Contractor estimates and receipts for home repairs after the flood
- Insurance documents (declaration page, denial letter, settlement statement if applicable)
- Rental assistance appeal documents (temporary rental receipts, utility bills, etc.)
- Transportation assistance (valid registration, mechanics estimate if vehicle damaged)

Note: Additional documents may be needed based on your specific situation.


