
Legal Needs Assessment Results Are Here



In-depth Interviews

AppalReD Legal Aid Service Area



AppalReD Legal Aid serves 37 counties throughout eastern and south-central Kentucky. Approximately, 200,000 low-income people qualify for our services. It is no surprise that our region is one of the poorest in the nation.

Specifically,

- 35 out of 37 counties in AppalReD's service region have <u>lower median income</u> than the state average median income.
- 25 out of 37 counties in AppalReD's service region have <u>higher ALICE ((Asset Limited, Income Constrained, Employed) thresholds</u> than the rest of the state.
 These people are often considered the "working poor." The challenges faced by the working poor include low wages, lack of access to benefits and social services, limited education and training opportunities, poverty, and inequality.
- 19 out of 37 counties are considered <u>highly vulnerable</u> according to CDC Social Vulnerability Index.

ThredPartners found that there is a growing gap between Federal Poverty Line and Asset Limited income due to inflation and cost of living. More people need our services but find themselves NOT financially eligible but also unable to afford an attorney.

Key Takeaways

After analyzing Census Data, other demographic information, and survey, focus group and interview data, here are some key takeaways.

Housing Crisis: The housing situation has significantly worsened. The increased cost of housing, lower incomes, and the devastating 2022 floods have left many without homes. Some areas are no longer habitable, reducing the availability of affordable housing.

Family Unit Deterioration: The stress of poverty has increased mental health issues and substance abuse, leading to broken families. Over 50,000 grandparents are now raising their grandchildren, indicating a significant social shift.

Employment and Infrastructure Decline: The loss of coal mining and manufacturing jobs has led to a lack of reliable employment and essential services. Many are now dependent on low-wage, part-time jobs without benefits, making it difficult to meet basic needs.

Drug Crisis: The opioid epidemic has resulted in increased addiction, overdose deaths, and incarceration rates (particularly for women). Many individuals are unaware that their issues could be addressed legally, and social services are struggling to meet the demand for assistance.

<u>Legal Education Needs</u>: Community partners identified a need for more legal education Topics such as Family Law, Housing, Public Benefits, and Civil Rights were highlighted as areas where AppalReD could make a significant impact.

<u>Awareness of Free Legal Aid</u>: A significant portion of respondents were unaware of AppalReD and other free legal services. Increasing awareness and outreach is crucial to ensure equitable access to legal assistance.

<u>Disparities Among Minorities</u>: Minority communities face similar issues as white resident but have distinct challenges. Employment related legal issues were a concern. Significantly, while the population of eastern Kentucky has declined by five percent, populations of color have grown (Black residents by 4%, Asian residents by 26%, and HIspanic residents by 37%).

<u>Distrust in the Legal System</u>: Many community partners and respondents indicated distrust in the legal system, believing it favors individuals based on income or social status. Building trust through increased community engagement and awareness is essential.
