Description: This is an approach to engaging survivors, which recognizes the presence of trauma symptoms and acknowledges the role that trauma may play in their lives, while navigating the court system. Participants will gain insight into the significant impact of trauma on an individuals' health and life, and how that can lead to a sense of powerlessness, fear, hopelessness, and a constant state of alertness within an individual. This training will teach one practical ways to ease trauma while in court and related experiences, mitigate the risk of re-traumatization, utilize laws and protections for survivors, and address secondary trauma of the professionals providing services.


