**Prestonsburg, Kentucky**—As communities across Eastern Kentucky face the devastating aftermath of flooding, AppalReD Legal Aid is stepping up once again to ensure survivors receive the legal support they need to rebuild. With a dedicated Disaster Legal Services Team, AppalReD is ready to help individuals navigate the complex legal challenges that develop after a disaster.

Since the catastrophic floods of July 2022, AppalReD has assisted over 1,000 survivors with legal issues ranging from FEMA appeals and Disaster SNAP benefits to collections for flooded vehicles and clearing home titles. Now, as Eastern Kentucky recovers from another disaster, the organization is focusing on intake, outreach, and pro bono to increase capacity and reach even more individuals in need.

## **Free Legal Help for Flood Survivors**

Flood survivors facing denied FEMA claims, landlord-tenant disputes, lost documents, contractor scams, or other disaster-related legal issues can call AppalReD's Disaster Legal Services Intake Hotline at 1-844-478-0099 for free legal assistance. Survivors can also visit an AppalReD office, connect with staff at Disaster Resource Centers, or leave a message for a Disaster Team member to return their call.


